## **VOORSIENING VAN GRUIS EN ROOIGROND VIR PRIVATE DOELEINDES**

### **1. INLEIDING:**

Versoeke vir gruis en rooigrond vir private doeleindes ( op perseel) word gereeld ontvang. Hoofsaaklik weens stormwaterprobleme en rooigrond vir tuinmaak.

### **2. Huidige Beleid:**

#### **2.1 Gruis:**

Indien 'n versoek vir gruis ontvang word, word die aangeleentheid ondersoek en indien regverdigbaar, word 'n gruisgroef uitgewys waarvandaan die aansoeker self die gruis kan aanry. Hierdie versoeke is gewoonlik vir klein hoeveelhede, gewoonlik 'n bakkievrag.

Georganiseerde voorsiening van gruis word in wyksverband gedoen. 'n Opname word vooraf gedoen waarna gruis op strategiese plekke afgelaai word en die inwoners ry self die gruis aan na hul persele.

#### **2.2 Rooigrond:**

Die aansoek vir rooigrond word dieselfde hanteer as gruis. Weens die beperkte voorraad rooigrond beskikbaar, word dit nie aangemoedig nie.

Die Raad het wel 'n tarief vir die verkoop van rooigrond aan skole. (Die huidige tarief is R90.00) (BTW ingesluit) / vrag. (Raadsbesluit item 17 van 28 Oktober 1998 bladsy 15).

## **POLICY: PROVISION OF GRAVEL AND RED SOIL FOR PRIVATE PURPOSES**

### **1. INTRODUCTION:**

*Requests for gravel and red soil for private purposes (on site) are received regularly, mainly because of storm water problems and soil for gardening.*

### **2. Current Policy:**

#### **2.1 Gravel:**

*If a request for gravel is received, the matter is investigated and if it is justified, a quarry is identified from where the applicant may personally fetch gravel. These requests are normally for small quantities, usually LDV load.*

*Provision of gravel on an organized basis, occurs in ward context. A survey is conducted beforehand and gravel is then deposited at strategic points from where residents personally fetch gravel for their premises.*

#### **2.2 Red Soil**

*The application for red soil is dealt with in the same manner as gravel. Due to the limited supply of red soil available, it is not encouraged.*

*Council does have a tariff for the sale of red soil to schools. (Current tariff is R90.00 (including VAT) (CR item 17 of 28 October 1998, Page 15).*
