QUOTATIONS ARE HEREBY REQUESTED FOR THE IDENTIFICATION, VERIFICATION, COMPONENTISATION AND VALUATION OF ALL INFRASTRUCTURE ASSETS OF THE MUNICIPALITY WITHIN ITS AREA OF JURISDICTION.

Notice is hereby given in terms of Section 111 of the MFMA (No 56 of 2003) and Clause 12(1) of the Municipal Supply Chain Management Policy that Emthanjeni Municipality intends to appoint a service provider to conduct a verification of its infrastructure.

### **Specifications:**

#### 1. INFRASTRUCTURE ASSETS

The identification, verification, componentisation and valuation of all infrastructure assets of the Municipality within its area of jurisdiction.

- The categorisation / classification of ALL infrastructure assets must be reviewed.
- Documented proof need to be kept (for audit purposes) of how the verification was conducted and the condition assessments determined.
- It is important that the evidence is of such a nature that it will be sufficient for the auditors to place reliance thereon (for example in-time photographical evidence of all assets verified). For this reason, the use of Mobile Verification Application is highly recommended.

#### 2. VERIFICATION PURPOSES OF "ABOVEGROUND" INFRASTRUCTURE ASSETS

- The following is of importance for verification purposes of "aboveground" infrastructure assets:
- All "aboveground" assets (100%) need to be physically verified.
- During the verification, the condition assessments of all the "aboveground" assets need to be determined.
- It is further required that all "aboveground" assets are photographed and GIS features need to be created.

#### The following conditions shall apply:

- The Council is not obliged to accept the lowest or any quotation and reserves the right to accept any quotation or portion thereof.
- Quotations must be valid for a period of 90 days after the closing date.
- Emthanjeni Municipality's Supply Chain Management Policy will apply.
- Must register on the Emthanjeni Municipality Database.
- All documentary proof such as original tax clearance, BBBEE certificates etc. must be submitted along with the quotation.
- Quotation notice will be evaluated on 80/20 basis.
